1.) **Submission Requirements**

All Press Kits submitted to New Song Music.com become property of New Song Music.com. All material submitted should be copyrighted before submission. New Song Music.com is not responsible for copyrighting of music, neither shall New Song Music.com be held responsible for non-copyrighted material that may be infringed upon. All content submitted **must** adhere to the following guidelines:

- a.) **Bio-** Bios must be submitted in pre-typed format on a 3.5" floppy disk or CD.
- b.) **Photo-** Photos must be submitted in a pre-digitized format (i.e. JPEG, GIF, etc.) via CD.
- c.) **Demo-** Up to three (3) full length songs may be submitted.
